- 1. DEFINITION: National Patios ACT Khanacross Series (the Series) events will be held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, the CAMS Khanacross Regulations, the Passenger in Vehicle Guidelines, the ACT Khanacross Series Regulations, and the Supplementary Regulations issued for each event. This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au

	A clearing of the course, with assistance from all Competitors, will be followed by a short awards presentation at the completion of each Event (at approximately 4:30pm).		
DOCUMENTATION			
17. LICENCE	A valid CAMS Level 2NS/2NSJ Licence or superior must be presented at a documentation check. An <u>application</u> for a CAMS 2NS/2NSJ licence can be submitted through CAMS prior to the Event, but may be lodged with the Event Secretary, accompanied by payment of the applicable fee (\$85 for adults, \$35 for juniors/rookies, as at 11/05/2017).		
18. MEMBERSHIP	Valid membership to a CAMS affiliated car club (current membership card or copy of online membership renewal receipt) must be presented during documentation. You can join the LCCC online at: <u>www.lightcarclub.org.au</u> . LCCC standard membership or LCCC day membership will be available for purchase on the day of each Event.		

VEHICLE ELIGIBILITY

19. REGULATIONS	All vehicles must comply with CAMS Khanacross Regulations (available at <u>www.cams.com.au</u>).
20. EXHAUST NOISE	All vehicles must be adequately muffled.
21. LOG BOOK	If issued to a competition vehicle, a CAMS Vehicle Log Book must be presented at documentation.
22. LCCC CLUB CARS	The LCCC has Club Cars available for use by Junior/Rookie Competitors and novice Adult Competitors (up to a maximum of 3 events for adults). A \$10 charge to cover vehicle running costs and maintenance will apply for each person making use of a Club Car at each event. Competitors are reminded that the Club Cars are provided in good faith, and therefore these are to be driven accordingly. The Clerk of the Course retains the right to deny/retract use of Club vehicles as necessary.

PASSENGERS This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy. Passengers are only allowed where their role is as an 'Instructor'.

- (a) A Briefing must be attended by each Driver and Passenger (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of the Course prior to the MSPRA commencing.
- (b) Instructors must:
 - i. Be experienced and have the permission of the Clerk of Course. The suitability of the Passenger is at the discretion of the Clerk of Course.
 - ii. Wear the same protective gear as a Driver in accordance with Schedule D of the current CAMS Manual of Motor Sport.
 - iii. Be fitted and restrained as required for each Automobile with consideration for their physical attributes.
 - iv. Complete a Passenger Ride Entry Form and disclaimer.
 - v. Drivers must fill out a Passenger Ride Entry Form to ride as a Passenger.
- (c) Vehicles and Apparel used must pass Scrutiny.
- (d) Vehicles shall only carry one Passenger at a time, unless otherwise approved by CAMS.

23. CLASSES

- 24. Road Car Class: Open to 'standard daily driven road cars' which are fitted with road tyres only.
- 25. Rally Car Class: Open to purpose built **rally cars** which are fitted with **road tyres only**.
- 26. Buggy Class: Open to Buggy vehicles (4H vehicles).
- 27. Khana Special Class: Open to modified and themed vehicles particularly intended for Khanacross use only, and which are fitted with **road tyres only**.
- 28. Eligibility Vehicle eligibility for each class is at the discretion of the Clerk of the Course. Buggies will not be eligible for outright event or series awards.

CATEGORIES

- 29. Outright Open to all Competitors including those specified below
- 30. Junior Open to Competitors from 12 years to 16 years
- 31. Rookie Open to Competitors from 17 years to 21 years
- 32. Female Open to female Competitors only
- 33. Team Open to teams of 3 Competitors (refer to conditions below)
- 34. Eligibility Competitor eligibility for each class is at the discretion of the Clerk of the Course

TEAMS

- 35. Teams must comprise of 3 Competitors who have each registered for the full Series. No competitor may represent more than one team during the Series.
- 36. No team driver may drive more than one vehicle during the Series, **unless** a team vehicle is unable to continue in competition. Any change of vehicle will be at the discretion of the Clerk of the Course.
- 37. Teams must be nominated prior to any team member commencing the first test at an Event.

AWARDS & PRIZE MONEY

38. Trophies will be presented for the following categories at each event (where entries are received):

1 st Place Outright	2 nd Place Outright	3 rd Place Outright
1 st Junior Driver	1 st Rookie Driver	1 st Female Driver
1 st First Time Driver	1 st Buggy Driver	

- 39. Those Competitors entered in the full Khanacross Series will also accrue points towards overall series awards:
 - 1st Place Outright Series Champion
 - 2nd Place Outright Series Runner Up
 - 3rd Place Outright Series
 - Khanacross Series Team Award
 - Junior Khanacross Champion
 - Rookie Khanacross Champion
 - Female Khanacross Champion

- 40. ACT Khanacross Series Encouragement Award this will be awarded by the Series Director at the end of the Series, taking into account feedback from senior event officials. Development of car control abilities, general attitude and willingness to assist at events will all be taken into account when determining a winner.
- 41. Further prizes or trophies may be awarded at the discretion of the Organisers.

POINTSCORING

42. Points based on outright placings will be allocated as follows:

1st - 15 points, 2nd - 14 points, 3rd - 13 points, and so on to 15th place - 1 point

Points based on category placings will be allocated as follows:

1st - 10 points, 2nd - 9 points, 3rd - 8 points, and so on to 10th place - 1 point

A Competitor/team's 3 best event results and points will count if all 4 rounds are conducted. All results and points earned will count towards the Championship if three (3) or fewer rounds are conducted.

If Competitors tie at a round, the total points for the highest place they have collectively filled shall be equally shared among them.

If at the end of the Series, two or more Competitors have an equal number of points, a result will be determined by a count back of outright places at each event. If Competitors still tie after a count back of results, they will be declared equal status for the purpose of awards.

TIMING AND PENALTIES

- 43. Timing will be by hand held stop watches. Two watches per test operated by different officials, with one watch to be the master watch and the other as a backup. Timing shall be to 0.01 of a second and recorded as such
- 44. Penalties shall be applied as per the CAMS National Khanacross Regulations available at www.cams.com.au.
- 45. Timekeepers will be considered judges of fact for the application of penalties. Any enquiries relating to the application of penalties should be raised with the Clerk of Course in the first instance.

COURSE AREAS

- 46. A condition of the use of the areas for Series events is that the LCCC maintain the surface and surrounding areas. Competitors are reminded that without the use of these areas these events would not take place.
- 47. Each competitor is required to bring their own garden rake and/or shovel to assist with the repair of the course areas before final times and trophies will be issued. Each competitor is expected to assist with this task.
- 48. Competitors are required to take their rubbish with them upon the conclusion of events.

MISCELLANEA

- 49. Khanacross Events provide the opportunity for competitors to be assessed for an Observed Licence Test (OLT). A successful OLT is a requirement for gaining a higher level CAMS Licence. Competitors are encouraged to undertake this opportunity, and are required advise the Clerk of the Course and CAMS Steward/s prior to the commencement of the first test at this event of this requirement. Further details on OLT requirements are available at <u>www.cams.com.au</u>.
- 50. The Clerk of the Course may refuse any entry without assigning a reason in accordance with NCR 83.
- 51. Entries will be accepted in order of receipt. In the event of entries being filled to capacity, priority will be given to full Khanacross Series Competitors followed by new Junior/Rookie LCCC members, full financial LCCC members, LCCC day members and finally other CAMS affiliated car club members.
- 52. Entries on the day of each Event will be subject to availability and are not guaranteed to be accepted. Competitors are advised to submit an entry and appropriate payment prior to an event wherever possible.
- 53. Competition numbers shall be allocated at the discretion of the Clerk of the Course. Sponsor door plates and one pair of fluorescent numbers will be provided to competitors. For shared vehicles, one pair of door plates will be provided for the vehicle, along with a pair of numbers for each competitor to allow all numbers to remain on the vehicle during an event.
- 54. For timing purposes, it is important that Non-Competing Drivers in shared vehicles place a strip of black magnetic material (which will be provided where required) through their numbers if not undertaking a test.
- 55. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.
- 56. The Organisers may cancel, alter, abandon or postpone the event without assigning a reason in accordance with the provisions of NCR 59.
- 57. Protests, if any, must be lodged in accordance with Part XII of the NCR.

- 58. Spot checks for compliance with all Series Regulations will be carried out during the running of the event.
- 59. Any queries relating to these Series Competition Conditions or ACT Khanacross Series events should be directed to the Series Director.

ALCOHOL, DRUGS AND OTHER SUBSTANCES

61. Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
