Blue Range Rallysprint – Service Instructions

1. The Event

The Event will be known as the Blue Range Rallysprint and will be a S2 Multi Club Rallysprint. The event will be held within in Uriarra Forest ACT on closed public roads.

The Sunday Drivers component of the event will be conducted on public roads in the ACT and NSW.

The Blue Range Rallysprint is Round 1 of the 2019 Techworkz Automotive ACT Regional Rally Series.

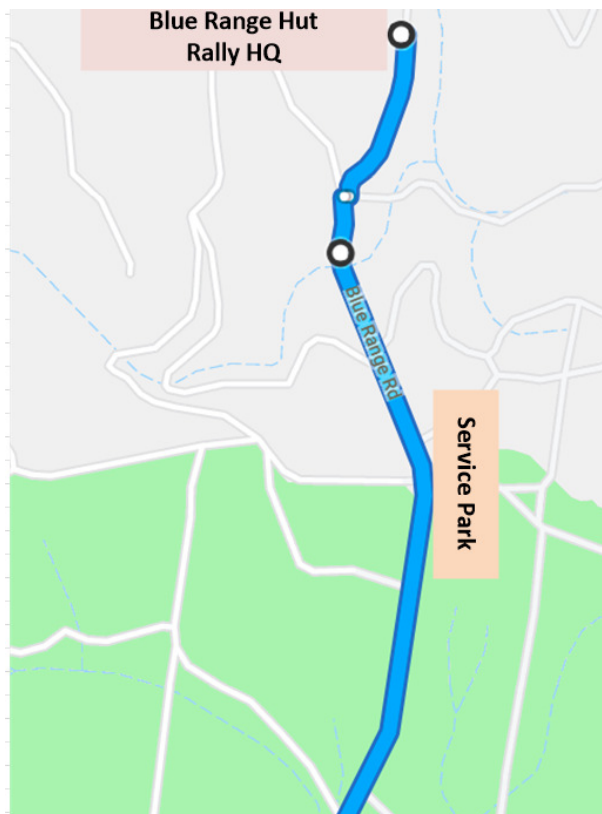
Cars will complete 5 runs for a distance of approximately 60kms. There will be a 2min gap between competitive cars.

2. Directions to Service Park

From the Brindabella Rd and Uriarra Rd intersection:

1. Head south on Brindabella Rd for approximately 5.1kms
2. Turn right onto Blue Range Rd (Look for the 'Rally Action' sign).
3. Travel on Blue Range Rd for approximately 1.8kms.

Note: Blue Range Rd is unsealed however; the road is in good condition.

Rally Head Quarters will be located at Blue Range Hut approximately 800m from Service Park on Blue Range Rd.

4. Service Area

Service Park is on Blue Range Rd as per the below illustration. Servicing is strictly restricted to this area and will be clearly identified on the day.

- There is **minimal** time allowed between **runs**.

NOTE: Service Park will be two way traffic, so please allow enough room for cars to pass.

Children must be supervised at ALL TIMES.

5. Imposed Speed Limit

The speed of all vehicles between Service Park (inclusive) and the Spectator Point must not exceed **20 km/h**. Failure to comply with this limit shall result in a report to the Stewards where a penalty may be applied to your crew.

The speed limit in all other areas of the forest is per the ACT Forestry limit of 40 km/h.

6. Refuelling

- Refuelling is allowed only in the Service Park, in the designated Refuel Area (refer to Service Park map).
 - The Organisers recommend that all Service Personnel wear neck to wrist to ankle fireproof clothing, balaclava and fireproof gloves during refuelling.
 - No servicing is allowed within the designated Refuel Area.

7. Food & Drinks

The Mt Rogers Scout Group Scout Group will be running a BBQ at the event. Please make sure you support this incredible community group.

The BBQ will be located next to Rally HQ at Blue Range Hut or within Service Park. This will be confirmed closer to the day.

- to release CAMS and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
 - my death;
 - any physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
 - the contraction, aggravation or acceleration of a disease;
 - the coming into existence, the aggravation, acceleration or recurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs;
 - that is or may be harmful or disadvantageous to me or the community; or
 - that may result in harm or disadvantage to me or the community,

howsoever arising from my participation in or attendance at the Motor Sport Activities;

- to indemnify and hold harmless and keep indemnified CAMS and the Entities to the maximum extent permitted by law in respect of any Claim by any person;
- to be bound to the rules, regulations and policies of the Entities; and
- to attend at or participate in the Motor Sport Activities at my own risk.

I understand that:

- nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of CAMS and the Entities as the supplier of Motor Sport Activities / Recreational Services;
- nothing in this document prevents the Entities from relying on any laws (including statute and common law) that limit or preclude their liability;
- nothing in this document excludes any term or guarantee which under statute cannot be excluded; however the liability of the Entities is limited to the minimum liability allowable by law;
- nothing in this document precludes me from making a claim under a CAMS insurance policy where I am expressly entitled to make a claim under that insurance policy; and
- CAMS has arranged some limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities. However, I acknowledge and accept that the insurance taken out by CAMS may not provide me with full indemnity for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities, and that I may have to pay the excess if a Claim is made under an insurance policy on my behalf. I agree that my own insurance arrangements are ultimately my responsibility and I will arrange any additional coverage at my expense after taking into account CAMS insurance arrangements, this document and my own circumstances.
